

Privacy policy of the Circolo Pareus Clubhouse

1. General definitions

We process personal data in accordance with the General Data Protection Regulation (GDPR). With respect to the terms used in the following privacy policy (including data controller, consent, data processor), we refer to the GDPR.

2. Information about the data controller

The data controller as defined in data protection legislation is

3. Data processing when acquiring membership to the club

In addition to fulfilling legal obligations, we process your personal data when joining the Pareus Club House and when using the services offered by it.

Scope, purpose and legal basis: When adding members to the club and providing the desired services, we only process the data that is necessary to fulfil our contractual obligations. We process personal data on the basis of Article 6 (1) (b) GDPR, insofar as this is necessary for the performance of a contract to which the data subject is a party or for the implementation of pre-contractual measures taken at the request of the data subject. In case of failure to provide the personal data, it will not be possible to join the Pareus Club House and make use of its services.

Recipients of the data: Pareus Service Srl, tax and legal advisors, public authorities (if required by law).

Storage period: We store the personal data of the members of the Pareus Club House for as long as necessary to fulfill the purpose for which it was collected, and at least until the end of their stay at the Pareus Resort. In all other respects, members' data is stored in accordance with the statutory storage obligations, in particular to comply with our accounting and fiscal obligations.

4. Rights of members as data subjects

Right to obtain information: Pursuant to Art. 15 GDPR, members have the right to request confirmation from us as to whether the personal data concerning them is being processed by us and, if this is the case, the right to obtain information about this data, further information and a copy of the data.

Right to rectification: Pursuant to Art. 16 GDPR, members have the right to correct inaccurate personal data concerning them. Members also have the right to request that incomplete personal data be completed.

Right to deletion: Pursuant to Art. 17 GDPR, members have the right to request that the personal data concerning them be deleted without delay.

Right to restriction of processing: Pursuant to Art. 18 GDPR, members have the right to demand that we restrict the processing of their personal data.

Right to information: If a member has exercised their right to a rectification, deletion or restriction of processing against the data controller, we are obliged to inform all recipients to whom the personal data concerning them has been disclosed of this rectification, deletion or restriction of processing, unless this proves impossible or involves a disproportionate effort. Members have the right to be informed about these recipients (pursuant to Art. 19 GDPR).

Right to portability: Pursuant to Art. 20 GDPR, members have the right to receive the personal data concerning them that they have provided to us in a structured, commonly used and machine-readable format and they have the right to request that this data be transferred to another data controller.

Right to make a complaint to a supervisory authority: If the members consider that the processing of the personal data concerning them infringes the GDPR, they have the right to make a complaint to a supervisory authority, without prejudice to any other administrative or judicial remedy.

Revocation right for consent: Members have the right to revoke (any possibly granted) consent at any time.
